Questions to expenses: Which budget pays for Staff? How much is the sportsclub yearly? Around 50.000 kr. Does the board in Usa River apply for funds? Yes, and they have been successful earlier.

We expect a loss of 100.000 kr for 2016.

Contingent is set at 50 kr.

We have a loss of 60 members, but have 320 in total now.
